6	PUBLIC PARTICIPATION: Signs at Three Oaks bridge are round the wrong way, need reversing <u>Cllr Carl Maynard</u> Was contacted by developers at Spring Bank, Butchers Lane (where the potholes and springs come through the road), a telegraph pole had gone through a pipe and was causing the issue , this has now been rectified so should be sorted Friars Hill – Advised by Community Match Funding that our entry was too late however it could not have been accepted for this March as we have not had a feasibility study carried out. This must be funded 100% buy the Parish Council, can cost between £500-£1000. Feasibility study should be agenda point for next meeting. Application (with feasibility study) needs to be in by end Calendar year. Need to clarify exactly what we require with application, BY to email to get a definitive list <u>Cllr Roger Bird</u> Bridge is now open.
