Eco Dwelling, conversion of Piggery building into garage and workshop, along with associated parking, landscaping and general site features that promote a high level of ecological interest RECOMMEND REFUSAL. FIRSTLY THE PARISH COUNCIL WOULD LIKE TO SEE THE TERMS OF THE ENF/87/20/GUE CARRIED OUT WITH THE REMOVAL OF THE SHIPPING CONTAINERS AND AN IMMEDIATE CESSATION OF THE BONFIRES. THIS SITE IS OUTSIDE THE VILLAGE DEVELOPMENT BOUNDARY AND IS NOT CONSIDERED AN EXCEPTION SITE. THE EXAMPLE OF THE EXISTING SCRAP YARD THAT HAS BEEN THERE FOR MANY YEARS AND A CARAVAN SITE THAT SUPPORTS THE LEISURE INDUSTRY ARE NOT SEEN AS A REASONABLE EXCUSE TO ENCOURAGE RIBBON DEVELOPMENT IN A.O.N.B 2 PREVIOUS APPLICATIONS TO DEVELOP THE SITE HAVE BEEN REFUSED. IF ROTHER DECIDE TO PROCEED WITH THIS THE PARISH COUNCIL WOULD LIKE TO BE CONSULTED AS WE ARE UNHAPPY WITH CERTAIN ASPECTS SUCH AS THE POSITIONING OF THE OIL TANK, THE SIZE AND WORKING OF THE REED BED, THE POSSIBILITY OF CONTAMINATED LAND DUE TO THE HISTORIC USE OF CHEMICALS IN CONJUNCTION WITH LIVESTOCK. WE WOULD ALSO LIKE MORE INFORMATION AS TO THE PROPOSED USE OF THE WORKSHOP TO ENSURE THERE IS NO COMMERCIAL ACTIVITY PLANNED THIS IS AN EXTREMELY NARROW RURAL LANE.
