	THREE OAKS BRIDGE – Reply received from ESCC 21 June advising that an assessment was made by Traffic and Safety Team and Sussex Police and that it is their view that as it stands, with the give way on the lower side of the bridge, that the current arrangement is such that "maximum forward visibility allowed by the existing road geometry is achieved for traffic giving way to oncoming vehicles". Also advising that "with the additional road markings, improved visibility to the warning signs and the installation of marker posts to deter footway parking/highlight the widened footway, it is the view of the highway authority that we have achieved the best possible option". Parish Council discussed and agreed that they still have concerns, that the marker posts are not fitted and that when they are the parking issue will just move further down the road.
